## The Tippecanoe Arts Federation After School Arts Program (ASAP) is open and free to all:

This program is designed to make a meaningful difference in the lives of youth in our community. ASAP breaks down barriers, inspires the creative spirit, provides gap programming for schools and home schooled students, and gives youth a positive expressive outlet.

## Your COMMITMENT is essential:

When you or your child enrolls in an ASAP class, the commitment to attend all classes is critical to both the program success and student success. Enrollment is limited. If you know you cannot attend more than one class, do not enroll.

## Where and When?

Most classes are offered at the Wells Community Cultural Center, 638 North St, Lafayette. Select classes will meet off site. (Please use the side entrance off the TAF parking lot, classes are held in the downstairs meeting rooms.) No classes will be held February 15, and March 28-April 3.

## Registration:

Advanced registration is required and is on a first come, first served basis. Because there is limited space for each class, we highly encourage registering as early as possible. The registration deadline for each class is one week before the class starts. Late registration will be accepted at the discretion of the instructor.

Again, students and guardians are **required to commit** to the program by attending all sessions of the class they enroll in. Students or guardians must call TAF, 423-ARTS, if they are unable to attend or will be late to class.

## Intro to Dance

**GRADES 1<sup>st</sup> – 4<sup>th</sup>**

**Thursdays, 4-5:15pm, January 14 – February 4<sup>th</sup> (4 sessions)**

They will also learn mixing, scratching, beat juggling, turntablism, and working with Serato – THE software for DJ mixing and production.

**WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK  
AND INDEMNITY AGREEMENT**

In consideration of Tippecanoe Arts Federation ("TAF") allowing the minor child named below to participate in TAF's After School Arts Program, on behalf of the minor child and his/her next of kin and/or any other legal and personal representatives, and on behalf of myself, I hereby Release and further agree to Indemnify and Hold Harmless TAF and its officer, directors, instructors, organizations, sponsors, venues and property owners where the programs take place, employees and other agents with respect to any liability, claims, demands, causes of action, damages, losses or expense (including court costs and attorneys fees) of any kind or nature that may arise out of, result from, or relate to the minor child's participation in the After School Arts Program, including but not limited to any claims caused in whole or in part by the negligence of the released parties. I further agree that if, despite this agreement, I make or anyone on behalf of the minor child or on my behalf makes a claim for liability against any of the released parties, I will indemnify, defend and hold harmless each of the released parties from any such liability that may be incurred as a result of such claim.

I understand that certain activities offered by the After School Arts Program are strenuous in nature and that TAF encourages parents registering children for activities of a strenuous nature to seek a physician's approval. With regard to all activities provided through the After School Arts Program, I agree that it is my sole responsibility to determine whether the minor child is sufficiently healthy enough to participate in such programs. I understand that there are inherent risks involved in the programs and I appreciate the nature of such risks. I hereby expressly assume all such risk, on behalf of the minor child and on my own behalf. I understand and agree that the released parties assume no responsibility with regard to transportation of the child to or from any program and that it is solely my responsibility to make arrangements for such transportation.

By signing below, I hereby warrant that I have read this Agreement carefully, that I understand its terms and conditions, and that I have signed this Agreement freely and voluntarily and intend my signature to serve as confirmation of my complete and unconditional acceptance of the terms, conditions and provisions of this Agreement on behalf of the minor child and on my own behalf. I further acknowledge and agree that this Agreement represents the complete understanding between the parties regarding these issues and no oral representations, statements or inducements have been made apart from this Agreement.
